Dr. Shigeno consistently maintained taking a patient-centered approach to healthcare, empowering his patients to be actively involved in achieving optimal health. Even in death, he was able to save people's lives by donating all available organs and tissue. 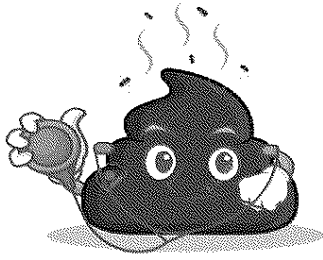

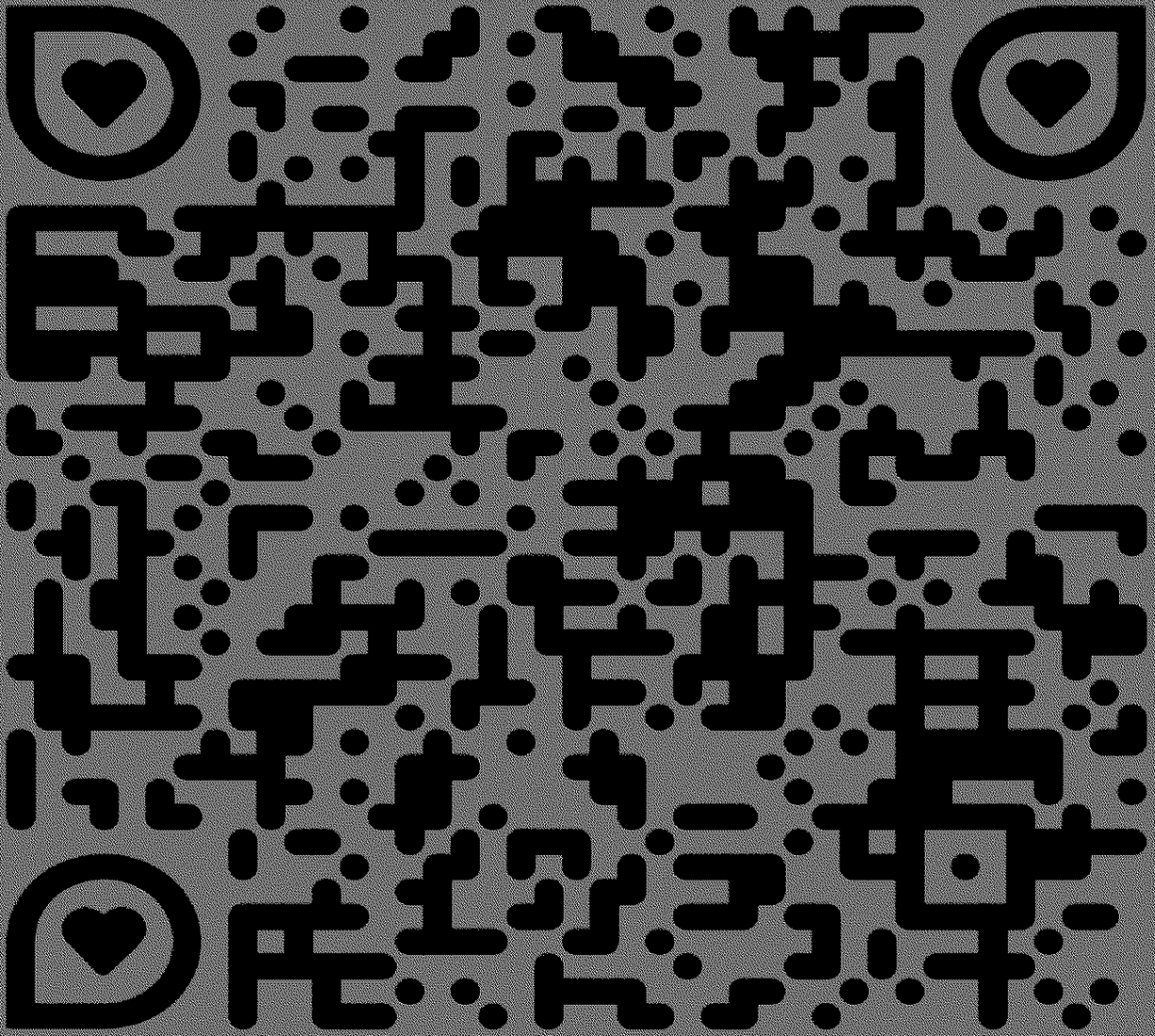
